Rules and Regulations

In order to ensure the maximum comfort and safety of all guests, we ask for your cooperation in observing the following rules and regulations in accordance with the "General Conditions of Accommodations, Article "10"

- 1. The use of any electrical appliances (such as hot plates, irons, etc.), other than those provided by this hotel, is not permitted.
- 2. Smoking in bed, or other places where fires are apt to occur, is not permitted.
- 3. The following articles may not be brought into the hotel:
 - a) Animals, birds, etc., except assistance dogs.
 - b)Articles with offensive odors.
 - c)Explosive and flammable items, such as gunpowder, gasoline, etc.
 - d)Illegally owned guns and swords.
- 4. Creating a disturbance which annoys other guests and gambling are not permitted in the hotel.
- 5. Meeting with visitors is not permitted in guestrooms.
- 6. Please do not use the guest rooms and lobby as an office, place of business or exhibition room or for any other purpose than lodging such as a location for filming commercial video.
- 7. Distributing advertising materials to other guests in the hotel is not permitted.
- 8. Ordering meals and drinks from outside of the hotel is not permitted.
- 9. Laundry will be kept for a maximum period of 30 days unless otherwise arranged.

 After that time, the articles will be disposed of as required by Civil Law.
- 10. We can not accept the care of goods such as art objects and antiques.
- 11. Rules Regarding Equipment and Fixtures on the Premises:
 - a)Do not use equipment and fixtures for purposes other than intended.
 - b)Do not take equipment or fixtures out of the hotel.
 - c)Do not remove equipment or fixtures from where they are.
- 12. Use of hotel rooms for purposes other than lodging is not permitted.
- 13. The hotel reserves the right to refuse a guest entry or accommodation when:
 - a)The guest is behaving in a violent, Intimidating, threatening, abusive or otherwise unacceptable manner:
 - b)The guest appears to be mentally or physically ill or under the influence of alcohol or drugs and is deemed to be unable to ensure his /her own safety or poses a potential danger, threat or insecurity to the guests:
 - c)The guest, while on the hotel premises, is shouting or singing loudly, making loud noises, or behaving in an otherwise unacceptable manner that causes a disturbance or annoyance to others, is gambling or offending public order and morals: or the guest is behaving in any manner similar to that described above.

NOTICE

- Safety deposit boxes are available at the Front Cashier, where money, jewels and other valuables may be deposited for safe keeping. Unless such articles are deposited with the Hotel, to be placed therein, the hotel will not be responsible or liable for any loss of, or damage to such articles.
- · Payment of your bill should be made upon check out or when presented with a bill for payment.
- Only one receipt will be prepared for each room. If two persons are staying in a room and need separate receipts, please notify the Front Cashier as early as possible.
- · You are kindly requested not to go out of your room in a nightwear or slippers.
- In the event you have requested your room not be cleaned for three days, we will clean the room on the fourth day of your stay for safety and sanitary purposes. This applies for guests staying three or more consecutive days.
- · Unregistered guests are not permitted in guest rooms.
